## What kind of data is collected?

To ensure optimal performance and user experience, the Salter Cook application (app) collects certain personal data. This data is essential for enabling key features of the app, including Bluetooth connectivity with the Salter scale, personalized content, and recipe sharing. Without providing this information, some functionalities of the app may be limited or unavailable.

The types of personal information collected include:

- Name used for personalisation within the app.
- **Email Address** required for account creation, personalisation, and sharing recipes with friends.
- Photos optionally used to enhance app functionality, such as attaching images to recipes. These are photos uploaded by the user at their own discretion, and users maintain control over what images they choose to share within the app. Images can also be imported from online sources to accompany recipes, but this is likewise at the user's discretion.

## Where is this data stored?

Personal data collected through the Salter Cook app is securely stored on Google Cloud servers located within the European Union, specifically in Belgium and the Netherlands. These servers are operated by GDPR-compliant service providers and are safeguarded using robust encryption protocols to ensure the confidentiality, integrity, and security of user data.

Data is also stored locally on the user's personal electronic device to support app functionality. This local data remains on the device until the app is deleted. Cloud-stored data will be permanently erased upon account deletion, as requested by the user, in accordance with data protection regulations.

# How can I view, share, or delete my data?

### **Viewing Data**

Salter Cook users are entitled to transparent access to their personal data, including user profile information and user-generated content.

While a full user profile is not currently viewable within the app, the email address associated with the account can be accessed by navigating to the *Delete Account* section. When initiating account deletion, the app drafts an email to the Ultimate Products Compliance Team, displaying the registered email address—allowing users to confirm the email linked to their account.

## **Sharing Data**

The scale does not store or process any personal data. Its sole purpose is to weigh items and, if desired, transmit the measurement to the Salter Cook app via a Bluetooth connection. The app itself does not facilitate the direct sharing of personal information. However, users may choose to share recipes with others via email or text message by entering a recipient's email address or mobile number. This sharing functionality is entirely at the user's discretion, and only the recipe content selected by the user will be transmitted.

Please note that data cannot be shared directly from the scale itself. Transmission functionality is only available when the scale is connected to the compatible Salter Cook app. The scale does not support integration or data transmission to other apps or platforms.

#### **Deleting Data**

Users can request the deletion of their account directly through the Salter Cook app. Please note that this process results in **permanent deletion** of all associated data—there is no option for temporary or soft deletion. Once the request is completed, all personal data stored both locally and, in the cloud, will be irreversibly erased in accordance with data protection standards.
